RE: Johnson and Rockwell Renovation Projects Update

This memorandum is to provide an update to the Public Building Site Committee with regards to the Johnson and Rockwell School Renvation projects. As you are aware, the project did pass referendum on October 17, 2017. Completion of the project, as outlined in the resolution is dependent on two (2) factors:

- Placement on the Priority List (December 15<sup>th</sup>) by the Office of School Construction and the Department of Administrative Services and
- Legislative approval of the School Construction Grant (Spring 2018).

Design work on the building will begin (per resolution) after placement on the Priority List. We have submitted all necessary paperwork for the Office of School Construction and are confident that we will be placed on the list.

In addition, we have met with the Office of School Construction multiple times to review the square footage to get closer in complying with the *Space Standards* set forth in the school construction guidelines. As you may be aware, we reduced the square footage at Rockwell School to stay within the building envelope. We also made reductions to Johnson to get closer to the Space Standards allowances. At our last meeting with the Office of School Construction we got verbal commitment for a Space Standards Waiver. They requested that I formally submit a waiver (attached). The waiver is important because it will allow maximize reimbursement for the projects.

Once we are placed on the Priority List, formal design work on the building is supposed to begin. I am happy to answer any additional questions you might have regarding the status of the projects.

Dear Commissioner Currey,

On behalf of the Bethel Board of Education, we are requesting a Space Standards Waiver from the Department of Administrative Services for the Ralph M.T. Johnson School - Project No. TMP-009-SBQL. The district has worked collaboratively with the Office of School Construction since last Spring and we have made the modifications to the site plans to meet the educational needs of our program and modified plans to fit within the existing envelope of the school building.

The community of Bethel has been working on the renovation of R.M.T. Johnson School for over 10 years. The building (1980), although well maintained has: (1) failing heating and ventilation systems; (2) is not ADA compliant; (3) does not meet current security and safety standards; (4) roof that is at the end of its lifespan; (5) electrical and utility systems are at capacity; (6) building code violations; (7) hazardous materials; (8) site traffic and circulation conditions which are unsafe; and (9) the current school does not meet the educational needs of the students.

Bethel <u>does not</u> have a declining enrollment. Although we conducted a second enrollment analysis by Milone and MacBroom which projected stable enrollment for the next ten years, our actual enrollment is trending higher than projected enrollment. As of today, our actual elementary enrollment (Pre-K-5) is 1482. According to the Milone and MacBroom study, our highest elementary enrollment in the 10 year project was 1370. We are exceeding it this year by 112 students.

The Director of the Office of School Construction was kind enough to come for a tour of the school in the spring of 2017. The space does not provide for the complexity of programs we are required to provide

our students and instructional and non-instructional storage. We do not have adequate intervention or special education spaces and are in violation of student confidentiality. We have worked as a district to create in-district special education programs to create fiscal efficiencies and better programs. In addition to pull out special education programs for students with learning disabilities, spaces were created for students with autism, multi handicaps and behavioral disorders.

The district, with community input, extensively studied the grade configuration of the district. On May 11, 2017 the Bethel Board of Education approved the educational specifications inclusive of a grade configuration which would make R.M.T Johnson a 3-5 school. This is widely supported by the community, as it allows all of our schools to be in three year increments (with the exception of high school). This means that over 200 (addition of a 3rd grade) students will be added to the existing school population. Many other options were considered: Build-as-New; do nothing; changing grade configurations; closing schools, etc.

Our team has met with the Office of School Construction several times to problem solve our space needs. We were able to come up with a solution, which does have some program sacrifices, but allows us to meet the needs of our students. As Bethel is a fiscally conservative community, the design reflects its values by minimizing any impact to the building structure and maximizing efficiencies to meet student needs.

In summary, R.M.T. Johnson School is designed to serve 3-5 students for the next 30-50 years. We have successfully collaborated with the Office of School construction to accommodate our program within the existing envelope of the building. We are respectfully requesting the space standard waiver (1,173 square feet) for the R.M.T. Johnson School.

On behalf of the Bethel Board of Education, we are requesting a Space Standards Waiver from the Department of Administrative Services for the Anna H. Rockwell School - Project No. TMP-009-DLTK. The district has worked collaboratively with the Office of School Construction since last Spring and we have made the modifications to the site plans to meet the educational needs of our program and modified plans to fit within the existing envelope of the school building.

The community of Bethel has been working on the renovation of Anna H. Rockwell School for over 10 years. The building (1970), although well maintained has: (1) failing heating and ventilation systems; (2) is not ADA compliant; (3) does not meet current security and safety standards; (4) roof that is at the end of its lifespan; (5) electrical and utility systems are at capacity; (6) building code violations; (7) hazardous materials; (8) site traffic and circulation conditions which are unsafe; and (9) the current school is too crowded to meet the educational needs of the students.

Bethel <u>does not</u> have a declining enrollment. Although we conducted a second enrollment analysis by Milone and MacBroom which projected stable enrollment for the next ten years, our actual enrollment is trending higher than projected enrollment. As of today, our actual elementary enrollment (Pre-K-5) is 1482. According to the Milone and MacBroom study, our highest elementary enrollment in the 10 year project was 1370. We are exceeding it this year by 112 students.

The Director of the Office of School Construction was kind enough to come for a tour of the school in the spring of 2017. The space is inadequate due to the overall student population, the

complexity of programs we are required to provide our students and instructional and non-instructional storage. We do not have adequate intervention or special education spaces and are in violation of student confidentiality. When the building was constructed Special Education laws and intervention programs were not existent.

The district, with community input, extensively studied the grade configuration of the district. On May 11, 2017 the Bethel Board of Education approved the educational specifications inclusive of a grade configuration which would make Anna H. Rockwell a K-2 school. This is widely supported by the community, as it allows all of our schools to be in three year increments (with the exception of high school). Many other options were considered: Build-as-New; do nothing; changing grade configurations; closing schools, etc.

Our team has met with the Office of School Construction several times to problem solve our space needs. Initially, our plan for Anna H. Rockwell School included a small addition for two (2) kindergarten classes. The Office of School Construction asked us to reevaluate the design to stay within the envelope of the existing building. We were able to come up with a solution, which does have some program sacrifices, but allows us to meet the needs of our students. As Bethel is a fiscally conservative community, the design reflects its values by minimizing any impact to the building structure and maximizing efficiencies to meet student needs.

In summary, Anna H. Rockwell is designed to serve K-2 students for the next 30-50 years. We have successfully collaborated with the Office of School construction to accommodate our program within the existing envelope of the building (11,225 square feet). We are respectfully requesting the space standard waiver for the Anna H. Rockwell School project number TMP-009-DLTK.
